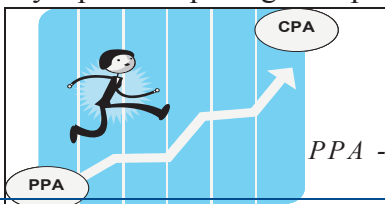
The Accounting and Business Law department is offering exciting events for accounting students! Together with Career Services Events, there's a lot to do! We hope these events will enhance your education experience.

# Timeline for Graduate School Application

To become a licensed CPA in Texas, you must first complete 150 hours of college credit. For most, it makes sense to get a graduate degree (30 hours) in addition to an undergraduate degree (120 hours). To make applying for graduate school easier, here's a handy timeline:

## First Semester of Senior Year:

Make appointment to meet with Director of Master's Programs.

Complete online application at <http://gradschool.tamucc.edu/application.html>.

Take GMAT (information at [www.mba.com](http://www.mba.com)).

Optional: Register to take 1 to 2 graduate courses second semester of senior year. (Assumes GMAT scores are acceptable.)

## Second Semester of Senior Year:

Submit goals statement.

Submit resume.

Submit two letters of recommendation.

If accepted to graduate school, meet with Director of Master's Programs to obtain departmental permission to enroll in first semester graduate school courses.

## Application Deadlines:

Fall Semester:	July 15
Spring Semester:	November 15
Summer Session I:	April 15
Summer Session II:	May 15

# AICPA's Accounting Scholars Leadership Workshop

I am a new graduate student in the College of Business. I recently represented Texas A&M-Corpus Christi at the 2011 Accounting Scholars Leadership Workshop, which was put on June 2-4 by the Minority Initiative Committee (MIC) of the AICPA. The Workshop gives minority students the chance to meet with other students studying accounting, as well as talk to, interact, and network with other CPA and accounting professionals.

The workshop's sessions were incredibly informative and interesting. There were group sessions on information technology, alternative certifications, financial planning, and even the CSO outlines for the new CPA exam with IFRS content. I found myself taking down notes on the advice they gave and information they showed us. We also had breakout sessions in smaller groups of about 20 where we got to ask 1-on-1 questions in a more



informal setting with CPAs on the MIC committee.

The AICPA event staff was incredibly helpful and anxious to be of service. They treated us as equals, and as future peers and colleagues, and that itself left a lasting impression with me. The Minority Initiative Committee poured out their confidence in us and their desire to see us succeed. The Committee created an alumni group on LinkedIn for us to stay in contact with each other. The event also set time aside for us to networking, trying to get everyone to meet everyone else at least once. I left home with a handful of business cards, having handed out over a dozen, and even from my own networking, my LinkedIn connections increased to 93 people, and my extended

network doubled to 1.3 million professionals.

The environment was also amazing. The hotel accommodations were absolutely incredible, and the Workshop treated us to all the meals, and even refreshments between sessions. This year's event was held in the Washington Duke Inn and Gold Club which resides on the Duke University Campus. Some of us ventured out into the forest near the golf course, and even toured the campus and went to the Fuqua College of Business.

**If I had to pick the one thing the workshop meant to me, it would be that it was a “call to arms” reminding me of why I picked this profession to study in the first place. Being in the company of brilliant accounting students from nearly every state in the country, and CPAs in positions ranging from CEO's to non-for-profit boards reminded me of the power, breadth and prestige the accounting profession holds.** The CPA license continues to be the gold standard in business-related certifications and the one thing that business professionals look for other than an MBA. One of the most memorable quotes was the “it's a war out there” and that the “CPA designation is your Howitzer.”

**The best part is, that the Workshop is an all-expenses paid event, the AICPA covers the cost of student attendees' transportation, hotel accommodation and meals.** You also get a free student membership with the AICPA. I did have to pay baggage fees (\$50 total, \$25 each way), but many students were able to get by with just a carry-on bag, since it is only a 3 day event. There was about an even split of male and female students, as well as an equal mix of undergraduate and postgraduate students. I met everyone from an accounting junior starting his core accounting classes, to a 1L law student was finished her CPA exam and was waiting to see if she passed.

I urge any accounting student to attend. I was proud to represent Texas A&M-Corpus Christi, and south Texas as the only scholar south of Houston. In fact, my project group and I actually won the case competition for the event! All this reminded me that accounting is a profession that doesn't care about your degree as much as it cares about that CPA license. We all have to pass the same test. Going to this conference will show you how others did it, and place you in the company of peers in the same boat as you. It was definitely an experience I won't forget, and when you drive away from Washington Duke Inn next year, you'll see what I mean.

CPAexcel is an online review course that with university professor created streaming video lectures and internet-based test prep software. ## TSBPA Education Requirements for CPA Exam Candidates

The Texas State Board of Public Accountancy has the following education requirements to become a candidate to take the CPA Exam:

- ◆ Hold a baccalaureate or higher degree
- ◆ Complete at least 150 semester hours
- ◆ Complete at least 30 semester hours of upper level accounting courses (at least 15 hours must be “in-class” rather than online)
- ◆ Complete 24 semester hours of upper level business courses
- ◆ Complete a 3 semester hour ethics course approved by the board (ACCT 5345 *Ethics for Accountants and Business Executives* is the approved course at TAMUCC)
- ◆ Complete a minimum 2 semester credit hours in research and analysis (ACCT 5371 *Tax Consulting, Planning and Research* is the TAMUCC course TSBPA recognizes to meet this requirement or you can satisfy the requirement if you have completed **both** ACCT 3321 *Federal Income Tax I* and ACCT 4311 *Auditing Principles & Procedures*)
- ◆ Complete a minimum of 2 semester credit hours in accounting or business communications (MGMT 3315 *Communications in Business*, ACCT 5341 *Advanced Auditing & Assurance Services*, and ACCT 5381 *Accounting Theory* are TAMUCC courses TSBPA recognizes to meet this requirement)

TSBPA lists specific upper level accounting and business courses that “count” and identifies courses that do not count. There are special rules that must be met in order for to have a 3 semester credit hour internship. Since TSBPA can change its rules at any time, it is important that you periodically visit their website:
